ORDER

However, the actual financial benefits shall accrue from the date of assumption of charge of the promoted post.

The above executive has to join the promoted post within one month from the date of issue of the order, failing which the Promotion Order is liable to be cancelled.

The above promotion shall abide by the ultimate adjudication in the Writ Petitions No. 19607(W) of 2017 with No. 9754 (W) of 2017 (Bani Singh Rana & Ors Vs CIL & Ors. with Pijush Kumar Singha & Ors. Vs CIL & Ors.) before the Hon'ble High Court of Calcutta.
