• Reservation for Scheduled Caste, Scheduled Tribe, Other Backward Class (Non CreamyLayer) and People with disability candidates is as per Presidential directives. - The upper age limit is relaxed by 5 years for SC/ST, 3 years for OBC (Non Creamy Layer) and maximum 3 years for Ex-serviceman candidates as per GOI guidelines. PH candidates will have additional age relaxation of 5 years.
- These positions are mostly for coalfield areas and as such candidates willing to serve in coalfields may only apply.

- In addition to the basic salary mentioned in Scale, candidates are entitled to DA, Perquisites and other applicable allowances.
